SAN AGUSTIN PHASE III STEP OUT DRILLING DOUBLES WIDTH IN ZONE 2

Vancouver, B.C., May 12, 2008 – Geologix Explorations Inc. (the "Company") is pleased to announce that Phase III drilling has doubled the width of Zone 2 from 250 metres to 500 metres on Section 350, (Click here for Link) which remains open in all directions. The Phase III drill holes on Section 350 have increased the area of mineralization by 175% on this section relative to Phase II drilling and the results confirm that grade is increasing with depth. The Company is currently commencing deeper drilling in these areas as holes end in strong mineralization. Dunham Craig, President and CEO stated: "We are extremely pleased with the Phase III expansion drilling on the project. Considering our company began receiving new drill results only one year ago, we are impressed with how the mineralization is rapidly expanding and showing very good continuity. Our past years work is currently undergoing a new resource calculation up to the end of Phase II drilling and we look forward to upgrading this preliminary resource with the Phase III results later in the year."

Quality Assurance & Control

The Company has implemented a quality assurance and control (QA/QC) program to ensure sampling and analysis of all exploration work is conducted in accordance with the best possible practices. The drill core is sawn in half with half of the core samples shipped to ALS Chemex Laboratory Services Limited in Vancouver, British Columbia for analysis. The other half of the core is retained for future assay verification. The QA/QC policy includes the chain of custody monitoring, insertion of blanks, standards and duplicates in the initial samples submitted. The laboratory provides an additional internal control program.
